### **DEBT: GARNISHMENT & EXECUTION**

Likewise, if you want to claim all or part of the money in your bank account as exempt from garnishment, you should file a "claim exemption" in the court which issued the writ of garnishment. As in the case of wage garnishment exemptions, you must state your reasons. After filing the list, you should mail copies of it to:

#### **Return of Title IV Funds (R2T4) - U.S. Department of Education**
