### **CDTFA-269-A (FRONT) REV. 10 (3-18) BEER AND WINE ...**

Pursuant to Alcoholic Beverage Tax Regulation 2538, every beer and wine importer shall on or before the 15th day of the month following the close of each reporting period, file form CDTFA-269-A showing all shipments of beer and wine received from a point outside of California A wine grower holding both a winegrower's license
